## Class or Wealth

In the texts, *Jane Eyre* and the *Wide Sargasso Sea*, many of the characters were affected socially by their class and wealth on several occasions. The people in the town treated Antoinette's family horribly once they were no longer wealthy, then Antoinette's mother ended up marrying Mr. Mason. However, based on Wide Sargasso Sea, the hatred against the family grew even more, and that's when the family got back to their financial stability status. Antoinette's issue arises from the hatred she receives from "negros," I never looked at any strange negro. They hated us." (*WSS*. 13). Since Antoinette is dealing with racial prejudice in the form of bullying, she begins to see herself as what they call her, "a white cockroach" which would make her feel paranoid. It didn't matter whether Antoinette's family were rich or poor they were still being threatened and attacked by the people around them, and they were living with fear. "Yet one day when I was waiting there I was suddenly very much afraid…" (*WSS*. 18). The hate for the family has changed from insults and mocking in the streets to creating a vast, frightening, at the home of Antoinette's family. Nonetheless, wealth also had a powerful impact on Mr. Rochester's life and how he got to meet Antoinette in the story of Jane Eyre. "Yet as little could he endure that a son of his should be a poor man. I must be provided for by a wealthy marriage", (*JE*. 121) meaning that Mr.Rochester had met Antoinette to serve Mr. Rochester to be the financial stability.
